WASHINGTON LETTER.

From Our Regular Correspondent.

WASHINGTON, D. C., June 26, '99.

The political busybodies are all working over-time seeking to array President McKinley on one side of the contest for the Michigan Senatorship, but it is a waste of time and energy. President McKinley is no more likely to take sides in this contest than is any other citizen of another state. Senator McMillan, who is a candidate for re-election, is his warm personal friend, and so is Secretary Alger, who has announced his candidacy. It is ridiculous to say, as some are doing, that the contest involves the control of the Michigan delegation to the Republican National Convention. It does nothing of the sort. It has been stated for months past by every Michigan republican in congress, and by Secretary Alger, that the Michigan delegation to the next National Convention was bound to be unanimous for the re-nomination of President McKinley, because that is the sentiment of the voters. What then could be President McKinley's object in interfering in the Senatorial contest? That contest will be settled by the republican voters of Michigan. Whether it will cause the resignation of Secretary Alger is a question that he can answer better than anybody else. It will not necessarily do so, but he may consider it expedient to resign, to remove any restraint that his candidacy might have upon the actions of the President, and also in order to better look after his own interests. That President McKinley would ask for his resignation because he was a candidate for the Senate is improbable. There is nothing about a Cabinet portfolio that operates to deprive its holder of any right possessed by private citizens. If there were, it would be as difficult for our President to get a Cabinet as it is for the President of France to get one. Secretary Alger is now in Washington, having just returned from a vacation, but he says he has nothing to add to what he has already said about his candidacy for the Senate.

Gen. Leonard Wood, former Commander of the Rough Riders, and now Military Governor of Santiago, has furnished additional proof that he is an extraordinary man, by declining an offer of \$50,000 a year to become president of the big syndicate which has bought nine of Washington's street railways and its two electric light companies and is preparing to put them all under single management, although the salary offered was more than five times the amount he receives as a Brig. Gen. of Volunteers. Gen. Wood will return to Cuba at once, because he believes it is his duty to do so. He speaks of his duties so in the most matter of fact tone. He said: "I intend to remain in the Military Service of the Government as long as the service needs me. I feel in

honor bound to return to Santiago, now that yellow fever is reported to have broken out there." Gen. Wood has doubts about the sickness at Santiago being yellow fever, recalling his experience there last year with a pernicious malarial fever, which caused men to drop in the streets, and which a number of experts pronounced to be yellow fever. Speaking of the Cuban situation, he said: "It is an easy matter to get along with the Cubans. You could not stir up a riot in Santiago today, if you tried. Everybody is contented for the first time in years. We have only to give the Cubans a good government, so good that they will be reluctant to do without it, and that is an easy matter."

It is expected that when President McKinley returns to Washington, he will issue orders for the recruiting of a volunteer force, not necessarily to be sent to the Philippines, but to be organized, drilled and kept in readiness as an emergency force, in case Gen. Otis should decide at any time that he needs more men than have been ordered to him. The administration isn't a bit worried about Gen. Otis, notwithstanding the raving of the hair-trigger editors about the danger he is in by reason of Aguinaldo's alleged preparation to attack Manila with his largest Filipino army that has yet been in the field. On the contrary, the administration knows that Gen. Otis would regard it as the greatest good fortune for Aguinaldo to march his army against Manila, for it would give him exactly what he has been trying so hard to get—an opportunity to fight a pitched battle with the entire Filipino army, and put an end to the revolt in short order. A little patience is sometimes a good thing to have. Gen. Otis is an experienced commander. He knows what he wants to do, the obstacles before him, and that he can have anything he asks for from the administration to accomplish what he is there to do. He has not had a single reverse since assuming command in the Philippines. Therefore, there is not a single valid reason for supposing that every Tom, Dick and Harry knows better what he needs and what he ought to have than he does himself, while there is every reason for confidently trusting that he will succeed in due time in putting down the revolt, and that none of the dreadful predictions of his failure will be realized.
