





Gold has been discovered in Norway. Aguinaldo is five feet four inches in height. The age of Aguinaldo is uncertain. It does not look like a human. THE WATERS REcede

The Situation at Pittsburgh is More Hopeful.

DANGER FROM FURTHER FLOOD OVER.

Factories Begin to Resume Work—Loss Will Approximate \$2,000,000—Three Persons Are Deceased.

Pittsburgh, Pa., April 23.—The flood is over. Notwithstanding the fact that early in the day there was every evidence of a resumption of the high water, the announcement can be made authoritatively that there is not the least danger of another rise at this point. The water has receded, but it is not yet out of danger because of rains in the valley Sunday night and Monday. All upper river points report the fall, and it is expected that the rivers falling. The Ohio registered 19.5 at the dam here at seven o'clock and falling. Forecaster Frank Ridge says it would require a steady downpour of rain for 24 hours to check the fall, and from present indications such a thing is not likely.

Factories Again Running.

The rivers about this city are down so that the work of the bridges are running. There is a good deal of cleaning up to be done. The flood brought in much sludge mud that it left when it receded, and it took a couple of days to remove it from many of the mills. In a number of places the mud has clogged up the machinery, some of which will have to be dismantled and cleaned. Losses Will Reach \$2,000,000.

Berlin, April 23.—It is believed in German official circles that Russia will take up negotiations with China again regarding the Manchurian convention after the general China question is settled. It is also believed officially that the Chinese regular army is already reorganizing, but the reorganization is under way, and that the allied commanders are now discussing what troops they can send home.

Chicago, April 23.—Ralph M. Esley, secretary of the National Civic Federation, announces the line of discussion to be pursued at the national conference to be held in Buffalo, May 23 and 24, under the auspices of the National Federation. WORKING FOR PEACE.

Aguinaldo Eager for Pacification of the Philippines.

URGES INSURGENTS TO SURRENDER.

Says He is Now Inclined to Believe That American Sovereignty is to Be Restored to Independence.

Manila, April 23.—A representative of the press visited Emilio Aguinaldo Monday afternoon at 56 Espana street, whether he was removed from the Malacanang, and found him in a large room upstairs, furnished with tables and chairs, smoking three cigars, and a typewriter. His wife who was entertaining a number of Filipino women, friends, sat at one end of the room while Aguinaldo, smoking a cigar and chatting with Benigno Legarda, the opposite corner. Other present were Gen. Col. John S. Mallory, of the Forty-first volunteer infantry, who has charge of Aguinaldo's guard, Gen. Albert Aguirre, of the Third artillery, and Mr. Fisher, Gen. MacArthur's private secretary.

England has come to the United States and floated a \$50,000,000 loan with which to continue the Boer war. This is different than under the last Cleveland administration when our bonds were floated in England at a discount. Who says we are not prosperous?

Organized labor will give Governor Van Sant credit for the recommendation which result in the passage of a law making eight hours a legal day's work on all contracts for public improvement. Under the provisions of the new law contractors on state work must pay full wages for an eight hour day.

During the campaign of 1900 the Democrats talked loudly of what they would do if they controlled the legislature, and of what the Republicans "dare not" do. Let those who heard such talk calmly and impartially review the work of the Thirty-second session of the Minnesota legislature and give credit where credit is due.

Shippers of grain are given a new advantage in the law authorizing the railroad and warehouse commission to declare any station in the state a terminal and put in force such regulations as are desirable. This is an innovation that will prove highly satisfactory to the farmers and shippers in the grain producing districts of the state.

The Republican party needs nothing better than the record of the Thirty-second session of the Minnesota legislature on which to go before the people in the campaign of 1901. Every pledge made or tripled in the campaign of 1900 was religiously redeemed, and no duty was left undone. A system of financing which adds \$500,000 to the appropriations for public improvements and the betterment of the public service, and at the same time reduces the general tax levy nearly 5 per cent, must speak for itself, and that is exactly what has been done.

The primary election law was passed in direct response to the expressed will of the people. The newspapers of the state, almost without exception, favored the bill and the governor had given it his endorsement. There was, of course, some opposition, but this opposition came mostly from country districts, whose members feared that it was to long a stride to take. The cities were, almost without exception, in favor of it, and it received a majority which conclusively showed that the public was behind it with a vote of approval.

The Washington correspondent of the Brooklyn Eagle writes his paper that President McKinley may soon wipe off the tariffs laid by congress, in disregard of "our plain duty," upon imports from and of Porto Rico. The act limited the duration of the tariffs to two years, but contained a provision that when the internal revenues of the island equaled expenses, the president might remove the duties levied on imports from the island and the Porto Rican duties on imports from this country and establish the same freedom of trade that exists between our other territories and the states. He says that Gov. Allen accuses the president that, while under the Hollander tax act, which levies a land tax, much to the disgust of land owners, the revenues will very soon meet all expenses, and that the president is determined to perform "one plain duty" the moment that condition is reached.—St. Paul Dispatch.
