Common School District Bond

Common School District No. 69 in the County of PINE and State of Minnesota for value received, hereby promises to pay on the first day of July, A. D. 1913 to the State of Minnesota and at the office of the State Treasurer in the City of St. Paul, Minnesota, for the Permanent School Fund, of said State the sum of Twenty Five Dollars together with interest thereon at the rate of four (4) per centum per annum payable annually on the first day of July, of each year, until paid.

And The School Board for said Common School District No. 69 hereby certifies that this bond is issued, executed and delivered by virtue of a vote of the electors of said District, duly taken at an election, heretofore duly called and held therein, at which a legal majority of all the electors, voting thereat, cast their ballots in favor of the issuance of this bond and authorized its sale and delivery to the State of Minnesota, and a resolution of said School Board thereafter duly adopted by a majority vote at a duly called meeting of said Board, at which a majority of all members thereof were present, and further certifies that in all things the Constitution and Laws of the State of Minnesota have been fully complied with in the issuance thereof. And for the faithful performance of all the conditions of this bond the faith and credit of said District is hereby irrevocably pledged.

In Testimony Whereof, said School Board in behalf of said District, so authorized, has caused this bond to be executed this 16th day of April A. D., 1908, by the Chairman and Clerk thereof.
